

COMMUNITY REGULATIONS - GREENE HILLS FAMILY CAMPGROUND & RV PARK

GENERAL INFORMATION

- The minimum age for renting a site is 18 years.
- Failure to leave the campsite in the same condition as it was found when rented is reason for refusal of requests for future reservations or rental.
- Please be respectful of other campers and the sites they are on. Do not take shortcuts through the other sites or remove items from those sites without permission.
- Smoking is prohibited from all common areas and buildings including the pool area.
- Campfires are to be limited to the fire rings provided and not moved.
- Entrance to the Little Juniata River for any reason will be at your own risk. The Susquehanna Conference of the United Methodist Church, its Camping and Retreats Commission, nor any of the agents of the conference will assume any responsibility or liability whatsoever for persons who enter the river. Please respect the privacy of site residents and use public campground areas for access.

CHECK-IN

- Check-in is 3:00pm. All guests are to check in at the campground office. Requests for preferred sites are noted, but not guaranteed. The management will assign all Campsites and cannot guarantee specific sites.
- There will be only one pop-up or RV unit per site, and each site is permitted a maximum of 5 lodgers per night per base rate.

CHECK-OUT

- Checkout is 2pm for campsites and 11am for rentals. Please restore sites to original condition and return rental keys to the office. Management reserves the right to charge additional fees to persons wishing to extend time beyond checkout.

NOISE

- Quiet hours are from 11 p.m. until 7 a.m. Electronic entertainment devices must be at a volume that cannot be heard beyond the site.
- An adult must supervise children at all times.
- Guests/occupants are expected to behave in a reasonable manner so as not to cause annoyance to others. Any person creating a disturbance deemed to be a threat to themselves or others, using profane or obscene language, behaving drunk or disorderly, or displaying immoral or lewd behavior will not be tolerated.

PAYMENT

- A one-night non-refundable deposit is required to guarantee a reservation. The balance is required at the time of arrival.

CANCELLATION

- Please notify the camp office if a cancellation is necessary. Deposits are non-refundable, but may be applied to a visit later in the same season or designated as a donation to the camp.

PETS

- Maximum of two pets per campsite are permitted using 6' leashes. At no time are pets to be unattended. Pets will not be allowed to become a nuisance to other guests (including barking). Guests are responsible for cleaning up after their pets anywhere on the grounds.
- Pets are prohibited from entering the restroom/shower house facility and pool area. It is expected that all pets have current rabies vaccinations.

PLAYGROUND

- The playground is designed for use by children ages 11 and younger under the supervision of an adult at all times.
- Guidelines are posted at the playground area.

VEHICLES/PARKING

- Because of limited parking space, only 2 motor vehicles allowed per site (not including camper unit). Please use the overflow parking area whenever possible.
- Recreational all-Terrain Vehicles may not be operated on Greene Hills Camp property. We ask that vehicular traffic on the grass be limited to as seldom as possible.

- As a safety precaution, there is to be no bike-riding after dark.
- Vehicular use of the Cart Path at the West end of the campground (tent area) is limited to staff only.

TRASH/WASTE WATER

- Bagged trash is to be deposited in the dumpster when you vacate your site. The dumpster is located conveniently near the exit of the park. Greene Hills does not provide disposal service for non-household garbage. Items such as awning parts, chairs, appliances, grills, oil, mattresses are prohibited from the dumpster.
- The dumping of waste water anywhere other than in the designated Dumping Station is strictly prohibited and against PA state regulations.
- If you use waste water treatment chemicals, please choose products that contain no formaldehyde. Please use a biodegradable chemical.

GUESTS

- Guests who are not visiting a registered campsite are required to register at the campground office and obtain a \$5/day parking permit which is to be displayed on the dashboard of the vehicle.

AMMENITIES

- **Firewood**, located in the woodshed across from the bathhouse is \$10/wagon load. Payment is on the honor system and may be deposited in the wooden box on the inside wall of the woodshed.
- **Bagged ice and ice cream products** are located in the freezers by the bath house. Payment is on the honor system and is to be deposited in the labeled depository on the wall of the bathhouse.
- The **campground washer and dryer** are available for camper use Tuesdays through Saturdays. Payment is to be made in the wooden box on top of the washer. Campers are expected to provide their own laundry products and be sure that the machines and filters are cleaned for the next use. No dyes or bleaches are permitted to be used.
- The **picnic pavilion** is available for general use, unless advance reservations have been made.

PHOTOGRAPHS

- Entrance onto the property constitutes permission to Greene Hills Family Campground & RV Park to photograph the guest or visitor while on premises and use any resulting pictures for any lawful purpose without payment to guest or visitor.

PROHIBITED

- The washing of vehicles and campers is not permitted at the Greene Hills Family Campground & RV Park.
- The use of generators is not permitted.
- Display of alcoholic beverages is not permitted.
- The use of alcoholic beverages, firearms (including BB & Pellet guns), Fireworks or illegal drugs is strictly prohibited, and can result in immediate expulsion from the property.
- The operation of chain saws and the cutting or carving of any sized trees is strictly prohibited.
- Neither the removal of hot water from the restroom, nor the use of the restrooms for washing dishes, utensils or clothing is permitted.

Expulsion from the Property - The management reserves the right to request persons to leave the grounds for the non-compliance of any of the above community regulations. Failure to comply with the request to vacate will constitute trespassing, resulting in the management notifying the proper authorities.

NOTICE: The management reserves the right to deny access to the campground to anyone or any group that has not complied with the above community regulations on prior occasions.
